- Admission must be based on a merit rank achieved in state or national-level entrance exams.
- Applicants must have scored 85% or above in their 12th standard arts stream.
- The annual family income of applicants must not exceed INR 4,50,000 from all sources.
- Children of employees of Adani Group and Buddy4Study are not eligible.

Annual tuition fees up to INR 50,000 per year

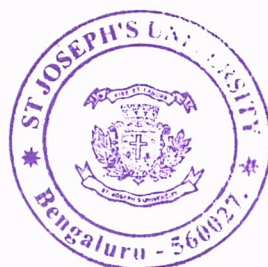

- Entrance rank certificate
- Counselling letter for seat allotment

- Fee structure for the course issued by the college
- Parent's or guardian's declaration
