Two-Wheeler Parking for Students

The specific regulations that the students need to follow, as per the Motor Vehicles Act, it includes the following key points:

- 1. **Helmet Mandate (Section 129):** Mandatory wearing of a helmet of ISI standard while riding a motorcycle in public places.
- 2. **Production of Documents (Section 130)** Carrying relevant documents such as driving license, certificate of registration, certificates of insurance, and applicable permits and fitness certificates when driving a vehicle. These documents should be readily available for inspection by authorized officers.
- 3. **Duty of Vehicle Owners (Section 133)** Providing all necessary information to the police officers regarding the driver's details if the owner's motor vehicle is involved in any offense.
- 4. **Vehicle Inspection (Section 136):** Cooperating with authorized officers of the Motor Vehicles Department for the inspection of vehicles involved in road accidents.
- 5. Compensation for Road Accidents (Section 140): Understanding the liability to pay compensation in the event of death or permanent disablement resulting from a road accident, irrespective of fault. Also acknowledging the liability of the insurance company in such cases.
- 6. Vehicle Insurance (Section 146): Ensuring that vehicles are always equipped with proper insurance certificates as mandated by this section.

These regulations serve to promote safe and responsible driving practices among the students of St. Joseph's University, ensuring compliance with the Motor Vehicles Act.

- 1. All the students who wish to park their two-wheelers on campus have to register for the parking and collect their parking pass from the Admin Office Counter No. 3, after verifying the following below documents.
- 2. Students who register for parking need to have the following documents:
- Registration Certificate
- Driving License/Learner's Licence
- Insurance Certificate
- Pollution Under Control (PUC) Certificate either in hard copy or in DigiLocker
- 3. Students with electric vehicles without registration certificates need to contact the IT cell to manually register their vehicles. No charging points will be provided in the campus.
- 4. The vehicle registration fee will be Rs 1500/- and will be valid for the even semester.
- 5. The registration link will be active from 05 December 2024 to 11 December 2024.
- 6. All the students can collect their vehicle passes immediately after making payment online. The Parking pass will be issued only after verification of the Valid Driving License/ Learner's License of the student. The pass will be issued only between 1:00 pm to 1:50 pm and 3:00 to 4:30 pm.
- 7. Only the registered vehicle shall be allowed inside the campus with a valid pass.

- 8. Students are required to lock their helmets. The University will not be responsibility for any property lost.
- 9. Students are not allowed to park their vehicles around the campus or in the neighbourhood in order to avoid disturbing the residents. The University will not be responsible for students' vehicles illegally parked around the campus or in the neighbourhood.
- 10. According to section 190(2) of the amended Motor Vehicle Act, which came into effect from October 2021, causing air and noise pollution can now attract a fine of up to ₹10,000 instead of ₹1,000 earlier under the old Act (1988). So any modified vehicle will not allowed to park inside the campus.
- 11. As per a ruling by Supreme Court in 2019, it is illegal to modify a vehicle in such a way that makes it differ from the specifications provided by the manufacturer. Modifying a vehicle can lead to imprisonment of up to six months or penalty of up to ₹5,000 per alteration.
- 12. No Parking for vehicles in campus overnight without prior permission of the Registrar/Finance officer. Non-Adherence to the above rule, the vehicle will be handed over to nearest Traffic Police Station.

Procedure to apply for parking in Student Portal:

- 1. Login into the student portal with your user id and password.
- 2. On the top Right corner iii, click this icon and select Feed, you will get the application form to apply for parking, fill the required details and make the payment.

Note: Students are advised to select the desktop site version in the browser setting, if students are not getting the option **FEED** in the mobile application.

NOTE: Any violation of the said norms will lead to the cancellation of his/her parking pass and he/she will be debarred from bringing any vehicle to the campus during the rest of his/her studies in the University.

The University is committed to preserving the environment and reducing its carbon footprint. Accordingly, the students are encouraged to contribute through measures such as vehicle pooling, using public transport, use of electric vehicles etc. The University does not have a provision to charge electric vehicles on campus
